Arizona Dept of Revenue License and Registration is Required

Proof of AZ Dept of Revenue License and Registration must be submitted along with application, photographs, insurance, payment in full and a signed contract. Failure to provide complete information will forfeit your application. Once your information is on file and complete with us, we will only need an application for future shows. You must print your AZ Tax License number and City License on your application.

Upon acceptance of your application, Red Rose Inspiration for Animals, Inc. shall execute the Contract, and return a signed copy to you by mail for **NEW** artists with Red Rose, otherwise if you have done shows with us in the past we will confirm with you regarding space and availability by phone or e-mail upon receiving your application and payment in full. We suggest you call in advance to see if there is space in a particular show. Space is limited per category.
