CONTRACT FOR EXHIBITORS

Red Rose Inspiration for Animals, Inc. reserves the right to disqualify an Exhibitor for failure to comply with the rules and regulations and reserves the right to make final decisions concerning interpretation of all rules. Red Rose Inspiration for Animals, Inc. is an animal-based nonprofit (501) (c) (3) organization that is supporting the lives of various animals and will not allow Exhibitors at the events to display or sell items made from animals, such as and not limited to animal skin, and animal fur.

- 1) <u>CONTRACT:</u> This Contract, properly executed by applicant (Exhibitor) shall, upon written acceptance by Red Rose Inspiration for Animals, Inc. constitute a valid and binding contract.
- 2) <u>ASSIGNMENT OF SPACE</u>: It is understood by the Exhibitor that space will be assigned by Red Rose Inspiration for Animals, Inc.
- 3) <u>BUSINESS LICENSE</u>, <u>INSURANCE & AZ DEPT OF REVENUE</u>: Exhibitor must provide proof of Arizona Dept of Revenue License and Registration along with application, insurance, contract, and photographs for shows presented by Red Rose Inspiration for Animals, Inc. **Payment in full is required with your application.** Failure to provide will forfeit Exhibitor's application and participation.

<u>Business License with the City in Which The Event Takes Place</u> is required for Exhibitors continuing to do shows within city limits. **Business license must be displayed in the booth at the event.**

<u>Insurance</u> is required naming Red Rose Inspiration for Animals, Inc. as additional insured.

- <u>AZ Dept of Revenue and License and Registration</u> is mandatory. All Exhibitors are responsible for their own collection and payment and applicable sales taxes with the AZ Dept. of Revenue. Red Rose Inspiration for Animals, Inc. will not be held responsible for sales tax or insurance.
- 4) <u>SUBLETTING PROHIBITED:</u> Subletting, assigning, licensing, or sharing space by Exhibitor, or the use of space assigned to Exhibitor by anyone other than Exhibitor is prohibited. If two or more people collaborate to produce original work, each person must be identified on the application.

- Rose Inspiration for Animals, Inc. or the exhibit space applied for herein becomes unavailable because of war, fire, strike, government regulation, public catastrophe, act of God or the public enemy or other cause, Red Rose Inspiration for Animals, Inc. shall not be held responsible and will credit Exhibitor for a future show. Neither Red Rose Inspiration for Animals, Inc. nor any of its members, or representatives, advisors or property owners shall be held accountable or liable for and the same are hereby released from accountability or liability for any damage, loss, harm or injury to the person or any property of Exhibitor or any of its officers, agents, employees, or other representatives resulting from theft, fire, water, accident, or any other cause. Exhibitor hereby agrees to indemnify, defend, protect and hold Red Rose Inspiration for Animals, Inc. and its owners. officers, agents, employees and other representatives or advisors harmless against any and all claims, demand, suits, liability, damages, loss, cost, attorney fees, and expenses of whatever kind or natural which might result from or arise out of any action or failure to act of Exhibitor or any of its offices, agents, employees, invites or any representatives.
- 6) <u>COMPLIANCE</u>: The Exhibitor assumes all responsibility for compliance with all pertinent ordinances, regulations and codes of duly authorized local, state, and federal governing bodies concerning fire, safety and health, together with the rules and regulations of the operators and/or owners of the property wherein the show is held. No Exhibitor shall conduct a crime or similar activity. Unacceptable behavior, not following the rules and regulations, and misrepresentation of product may result in loss of space and all fees. Swearing, cursing and foul language, intoxication will not be tolerated. Exhibitors may not solicit or approach patrons outside of their booth area.
- 7) <u>FLAMEPROOFING:</u> All decorations used by Exhibitor must be flame retardant to satisfaction of local fire department.
- 8) <u>SECURITIES/SAFETY:</u> Security will be provided at night, but Exhibitors should fully protect themselves by carrying appropriate insurance coverage. Red Rose Inspiration for Animals, Inc. will not be responsible for the safety of exhibits against loss or damage by fire, theft, accident, or other destructive cause.
- 9) <u>PAYMENT OF FEES:</u> A payment in full is due along with application for events. (Make checks payable to Red Rose Inspiration for Animals, Inc.) Pay Pal is an option for an additional \$5.00 charge to Exhibitor. If the application is rejected payment will be returned in the full amount. No refunds on cancellations less than 16 days before the event. Cancellations prior to the 16 days before an event will be up to Red Rose Inspiration for Animals, Inc. to use its discretion as to determination as to refund and may possibly affect Exhibitor doing future shows. There is a charge of \$50.00 for Nonsufficient funds of checks written.
- 10) <u>DEFAULT:</u> Red Rose Inspiration for Animals, Inc. reserves the right to prohibit, close, correct, remove, or eliminate any exhibit or display or any part thereof including signs, printed matter, merchandise, visuals and catalogs or any conduct, action, noise or activity which Red Rose Inspiration for Animals. Inc. in its sole discretion determines is not suitable or in keeping with the show's purpose and character or whether the issue causing Red Rose Inspiration for Animals. Inc.'s corrective response is specifically covered in this contract or in the Rules and Regulation for Exhibitors.

- 11) <u>APPEARANCES:</u> Exhibitor's booth should be professional in appearance. It is required to have tables covered or draped to the ground and all tents should have white tops. All booth areas must be kept neat and clean. Stored items must be neatly put away, covered, and not detract from the appearance of the show. No signs displaying clearance or sale. You may not encroach on another Exhibitor's space. No stakes or displays may be driven into the ground, nothing may be affixed to trees. To protect your booth and those around you, professional looking weights are required.
- 12) <u>BOOTH SET UP AND REMOVAL</u>: Set up of the booth is to take place on the morning of the date of the event starting at and after 6:00 am and before 9:00 am. If your set up takes more than 4 hours you can make special arrangements with the promoter to set it up between 4 am and 7:00 am and set up at your leisure with your vehicle/trailer in front of your booth. Exhibitors must be on time and open for business before 10:00 am and must stay the full weekend.

Upon set up you should first unload at your booth space and then begin to set up your booth. Same with pack up do not bring your vehicle in until your booth is packed up. Don't block others who are trying to set up or tear down. Late set up and early pack up will not be allowed unless approved by the promoter.

Booth must be disassembled as early as 5:00 pm on the Sunday evening and no later than 8:00 pm. Exhibitor vehicles must be removed from the area by Sunday evening. Vehicles will not be permitted into the show area before 5:00 pm and all patrons should have left the show area.

- 13) <u>ADVERTISING:</u> Red Rose Inspiration for Animals, Inc will promote and advertise the events and your name or work may be displayed without your prior approval. Red Rose Inspiration for Animals may select any Exhibitor for promotional exposure.
- 14) <u>PETS:</u> Pets are allowed at the events, but they must have proper accommodation (crate or play pen) and having access to shade and water is required. They also must be vaccinated with a rabies shot and have a tag as proof. All pets must be people and animal friendly and on a leash. Animals must be well behaved.
- 15) <u>RESTROOMS</u>: Toilets and Hand Wash Station are provided for the exhibitors at the show. It is required that all vendors use the porta potties unless otherwise indicated.
- 16) PARKING: Exhibitors must park in the designated artist parking area instructed by the promoter.

All rules will be strictly enforced. Failure to comply with the contract and rules will eliminate you from future events. **Please apply as early as possible, availability is limited.
